Dear Oxford Residents and Businesses:

Effective August 1, 2007, the Regional Income Tax Agency (R.I.T.A.) will begin collecting municipal income tax for the City of Oxford. R.I.T.A. is a non-profit governmental agency established in 1971 under Chapter 167 of the Ohio Revised Code and is the largest municipal income tax collection agency in the State of Ohio. As of August 1, 2007, R.I.T.A. will serve 139 municipalities in 44 counties statewide. The City of Oxford has chosen the Regional Income Tax Agency to maximize the City's tax collection efforts. R.I.T.A. will be responsible for the administration and collection of all income taxes and will serve as an Agent of the City of Oxford in this capacity.

After August 1, 2007, all City of Oxford tax payments and tax forms, for current or prior tax years are to be sent to R.I.T.A. and not to the City of Hamilton. Tax filings and payments – for current year or prior tax years- can be completed online at www.ritaohio.com or by mail. We encourage you to utilize R.I.T.A.'s electronic filing and payment system which will be available after August 15th, 2007 for all Oxford taxpayers. This free service is fast, simple and secure.

Checks or money orders should be payable to the Regional Income Tax Agency or R.I.T.A. Please include your Social Security Number or Federal Identification Number on all payments and correspondence.


City of Oxford residents will receive a 2007 individual tax return by the end of January 2008. Please keep in mind that effective January 1, 2007 all City of Oxford residents are required to file a tax return or exemption certificate, if no tax is due to the City.

Business accounts will receive 2007 Net Profit and Withholding forms in the near future. If you have an existing account with R.I.T.A. and are already remitting withholding taxes for another R.I.T.A. municipality, simply add the City of Oxford withholding tax payment to the R.I.T.A. Form 11.


