April 13, 2017

ITEM 1
CALL TO ORDER

The Oxford Community Relations Commission Meeting of April 13, 2017 was called to order at 4:00 p.m. by Doug Elliott, Director. Those members present were: Patrick Meade, Dan Umbstead and Brian Revalee.

ITEM 2
APPROVAL OF MINUTES

Minutes of the March 9, 2017 Community Relations Commission Meeting.

Mr. Umbstead moved to approve the March 9, 2017 meeting minutes. Mr. Meade seconded. The motion passed unanimously.

ITEM 3
NEW BUSINESS

A. Introduction and welcome to new member, Brian Revalee.

Mr. Elliott introduced and welcomed new member Brian Revalee to the Commission and provided a brief background on the charge of the Commission.

ITEM 4
OLD BUSINESS

A. "Bystander" Training

Mr. Meade advised Ms. McMahon-Klosterman and Ms. Bolser noted at the last Commission meeting they would provide the Commission with additional information regarding "Bystander" training. Mr. Meade noted since Ms. McMahon-Klosterman and Ms. Bolser were not in attendance the Commission would address the training at the next meeting.

Ms. Brown voiced her concern regarding the Butler County School Resource Officer (SRO) noting Butler County Sheriff Jones recently made a public statement regarding illegal immigrants and his desire to work with ICE to help detain and deport illegal

immigrants. Ms. Brown advised she had sent a letter to Superintendent Kelly Spivey asking her what access the SRO has to personal information in the school system and what the procedure would be if the Officer did have access to personal information. Mr. Elliott noted the City of Oxford has an agreement with the School District for the City's School Resource Officer and suggested Ms. Brown find out what the agreement says for the County's School Resource Officer with the School District. Mr. Meade noted Ms. Brown brought up some interesting points and expressed his opinion her concerns did not fall under the Commission's purview. Mr. Meade advised he would find out if the County's School Resource Officer has legal access to student records and expressed his opinion the SRO would not be able to access the records on their own to try and find anything without a warrant. Ms. Brown provided a hypothetical situation regarding a student from another country getting into an altercation which the SRO would need to get involved and inquired if the report would go to the School District or the Butler County Sheriff's Office. Mr. Meade advised Ms. Brown should also reach out to the Talawanda School Board with her concerns.

ADJOURN

Mr. Meade moved and Mr. Umbstead seconded to adjourn at 4:37 p.m. The motion passed unanimously.
