NARRATIVE: Unit one began backing from their parking spot, traveling north, inside the parking lot at 300 S. Locust St. (Kroger). Unit two was traveling east inside the driving portion of the same parking lot lane that unit one was backing out of. Unit one struck unit two while backing and damaged the rear passenger side fender and wheel of unit two. Unit one suffered damage to the rear bumper. Both vehicles appeared to be cosmetic only, no disabling damage. Driver two stated she felt back pain after the accident but did not want to contact an ambulance, and would go to the ER if she needed to later. Both vehicles drove from the scene.

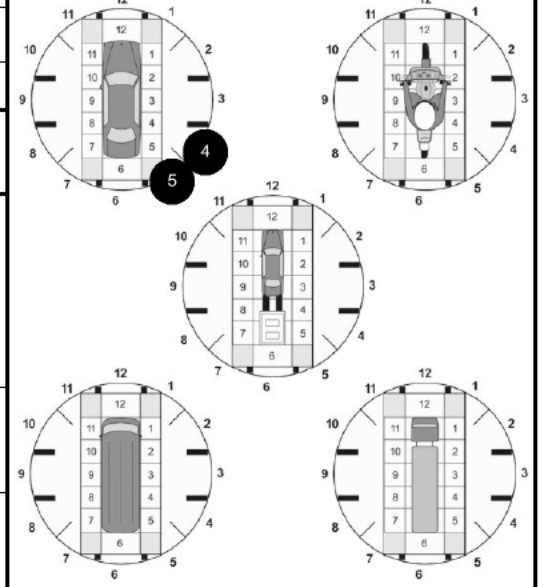

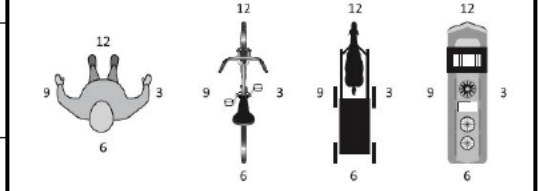
