Driver of unit three stated a vehicle in front of her stopped to turn into the cemetery causing her to apply brakes. Unit two stated she witnessed the vehicle in front of unit three turn and applied the brakes to her vehicle. Unit one stated she did not see the turning vehicle but noticed the vehicles in front of her stopping and applied her brakes but was unable to stop in time crashing into unit two. The crash from unit one into unit two, drove unit two into the rear of unit one.  Unit one suffered damage to the front end Unit two suffered damage the the rear end a minor damage to the front end Unit three suffered minor damage to the rear end  Unit one and unit two were towed by Carstar due to disabling damage. Unit three drove from the scene. All drivers were checked by medical on scene and refused treatment.

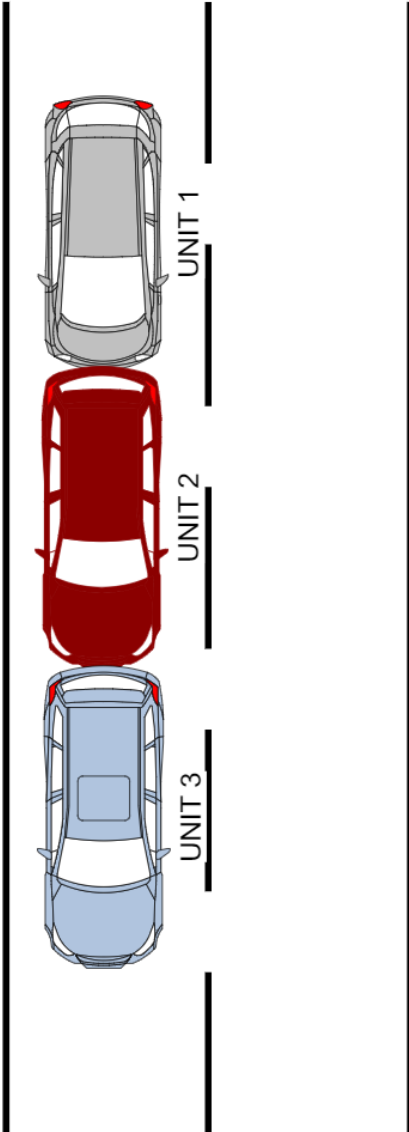
