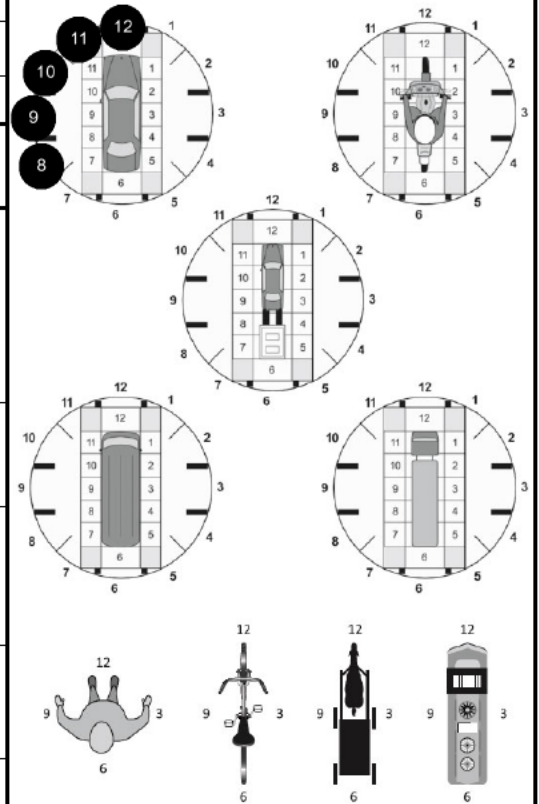

UNIT 1 WAS THEN STRUCK IN THE INTERSECTION BY UNIT 2. THE COLLISION PUSHED BOTH UNITS OFF THE ROADWAY TO THE WESTERN SIDE OF 732. UNIT 2 CAME TO REST NEAR A UTILITY POLE AT DANA/732. 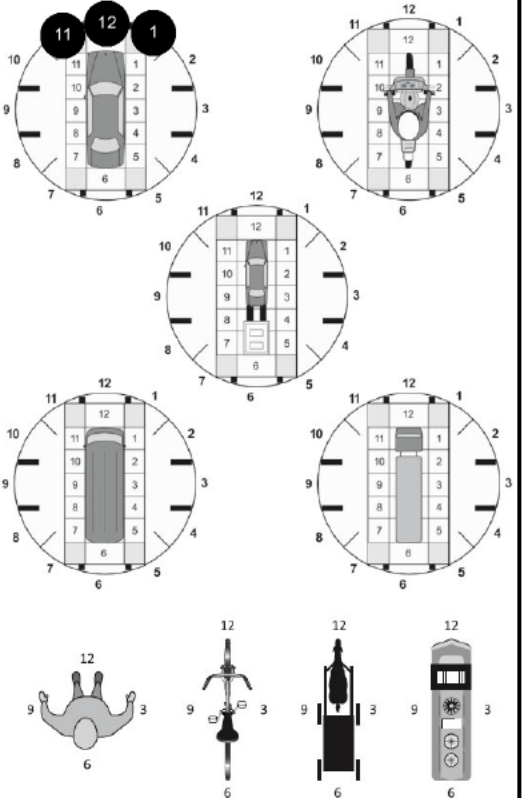
