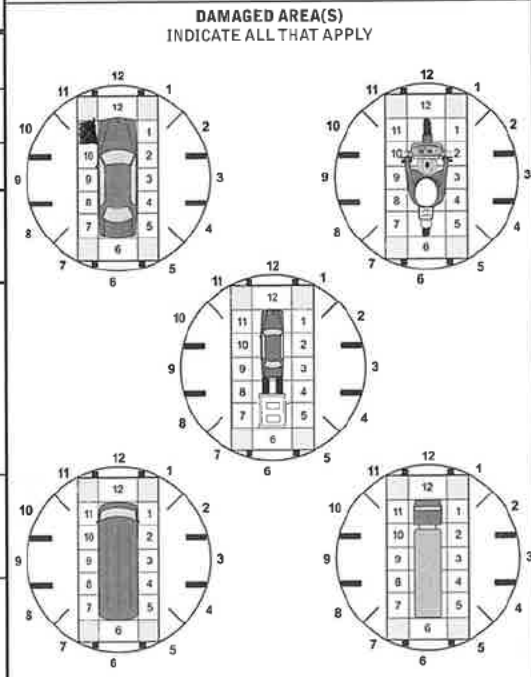
NARRATIVE, Diagram showing crash location on Homestead Ave and N. Campus Ave with vehicle positions 1 and 2.

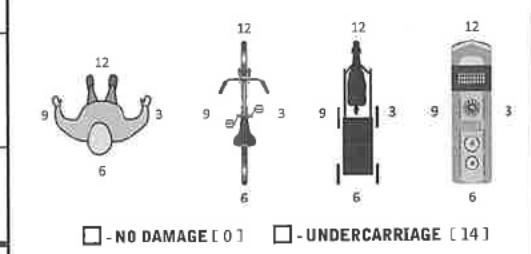
