The Unit 1 driver stated they looked both ways, did not see any vehicles, and proceeded through the intersection. Unit 1 driver advised that Unit 2 failed to stop at the stop sign and entered the intersection from the south, causing Unit 1 to strike Unit 2. Unit 1 driver advised they were on the phone with their mother. The mother reported Unit 1 driver said over the phone that Unit 2 ran the stop sign.</p> <p>The Unit 2 driver stated that it approached from the south and stopped at the N Campus Ave and E Church St stop sign. The Unit 2 driver stated they came to a stop, looked both ways and did not see any other vehicles. 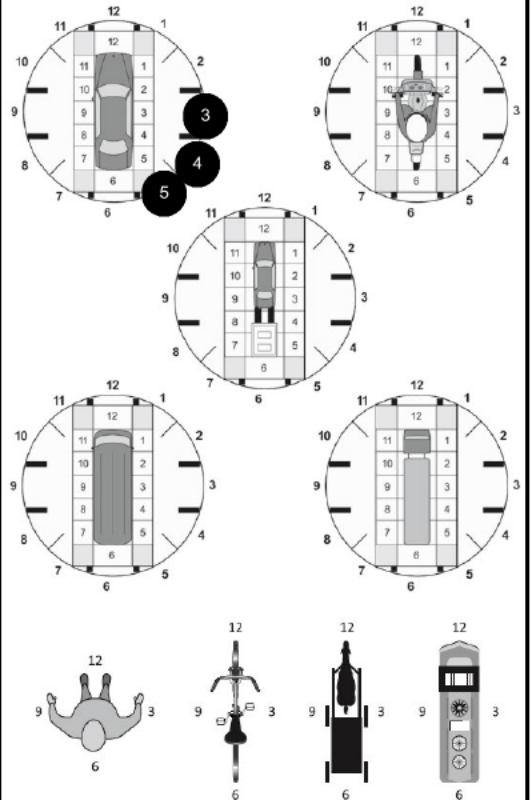
