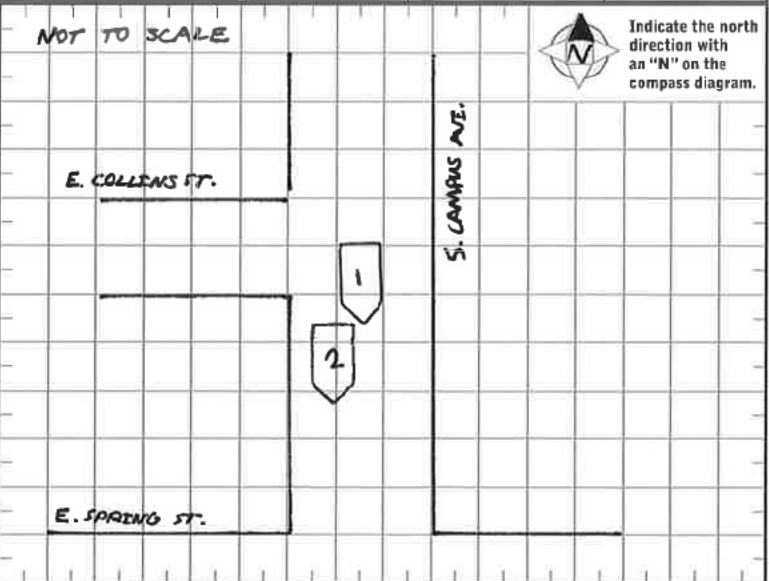

**UNIT 1 AND UNIT 2 WERE BOTH DRIVING SOUTH IN THE 200 BLOCK OF S. CAMPUS AVENUE, WITH UNIT 1 BEING DIRECTLY BEHIND UNIT 2. THE GAP BETWEEN BOTH UNITS BEGAN TO SHORTEN AND UNIT 1 ATTEMPTED TO AVOID A COLLISION BY BRAKING AND STEERING OFF TO THE SIDE. UNIT 1 WAS UNABLE TO STOP IN TIME, STRIKING THE REAR OF UNIT 2.**

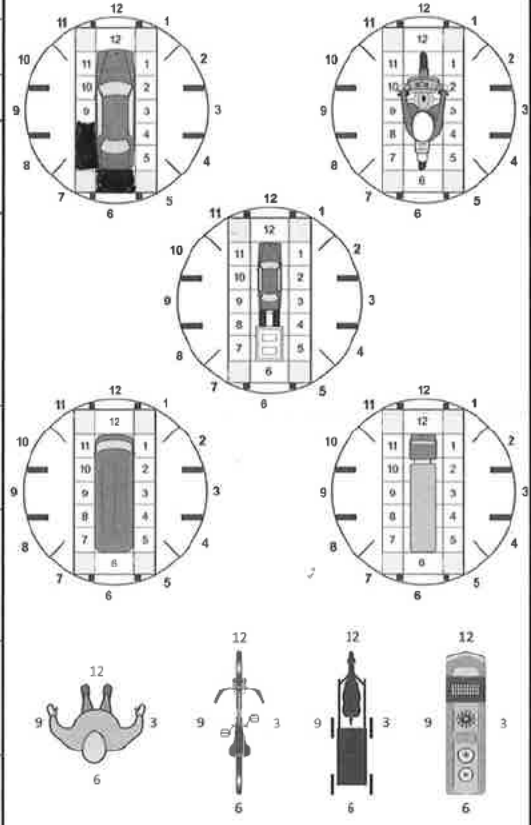
