High from northbound US 27 at Patterson Ave. Driver of Unit 1 went to go around Unit 2 and hit the rear left side of Unit 2 as it was making the right turn. Driver of Unit 1 did not stop and fled north on Patterson Ave. and then eventually parked behind Farmer School of business. I was able to speak to the driver of Unit 1 the next day and he admitted to leaving the scene of the accident.

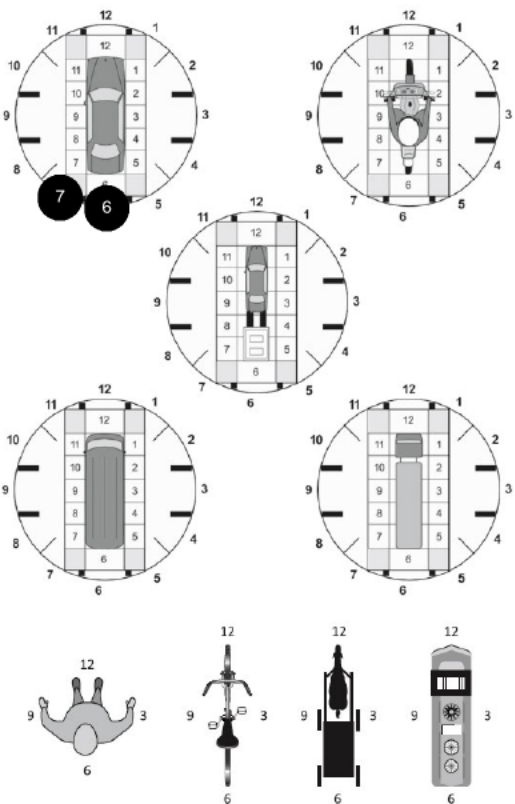
