He was walking from north to south and was initially struck in the front left side of his body. The pedestrian suffered bruising and a bloody nose but was standing upright and alert when I arrived on scene. He was then transported to the hospital by EMS for precaution. No visible damage to unit one.

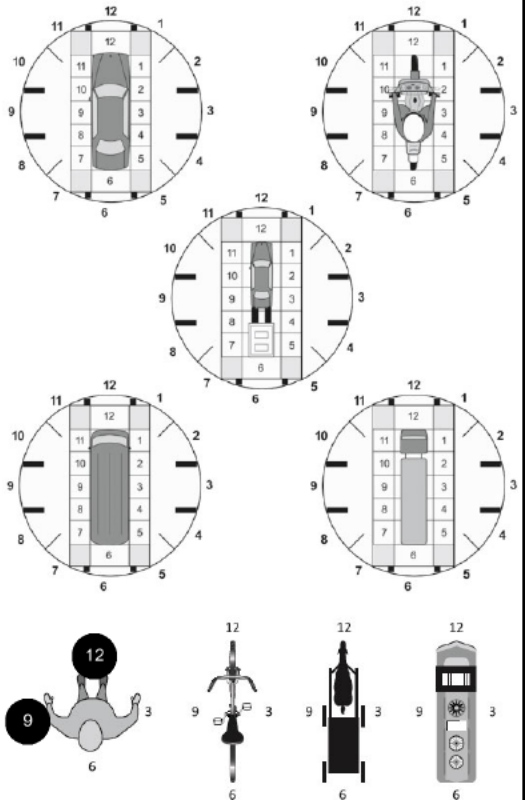
