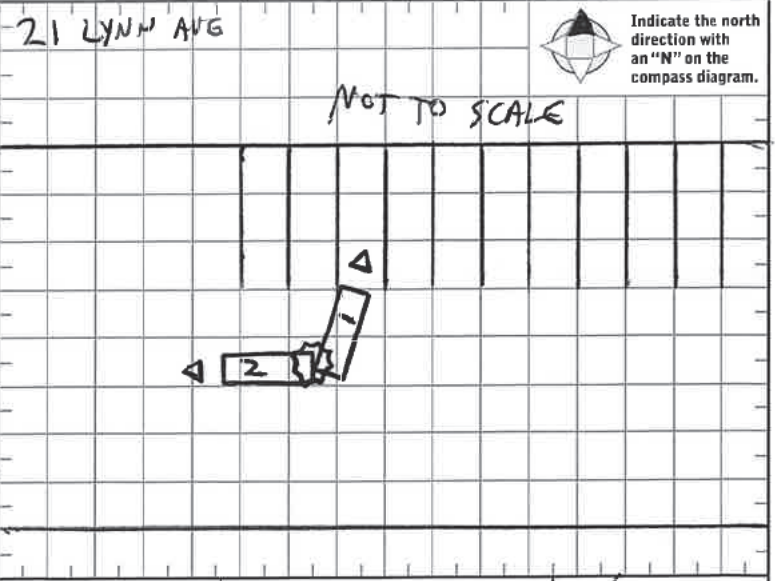

UNIT #1 THEN LEFT THE SCENE WITHOUT EXCHANGING THE REQUIRED INFORMATION FOR AN AUTO ACCIDENT WITH UNIT #2 OR POLICE. OCCUPANTS OF UNIT #2 STATED THAT THE DRIVER OF UNIT #1 WAS A MALE BLACK WITH SHORTER HAIR AND WEARING GLASSES. THEY STATED UNIT #1 WAS A 2000s MODEL SEDAN, POSSIBLY GOLD IN COLOR. THEY ALSO THAT THERE WERE HEADREST COVERS ON THE FRONT SEATS FOR THE ALPHA PHI ALPHA FRATERNITY.
