NARRATIVE Unit 2 was traveling southbound on N. Locust St. and was in the left turning lane to turn left on W. High St. Unit 1 was traveling southbound on N. Locust St. and was turning right onto Contreras Rd. Unit 1 was a gray or beige dually hauling a red or maroon camper. When unit 1 turned right the camper hit the rear passenger side of unit 2 causing the taillight to break, scratches and a dent in the rear panel. Unit 1 continued making its turn and was traveling westbound on Contreras Rd. A witness seen unit 1 hit unit 2 with the camper while turning onto Contreras Rd. The Witness continued southbound on S. Locust St. and turned westbound on Fairfield Rd. The witness then observed unit 1 turning right onto Fairfield Rd. from Lynn Ave. heading westbound. I was able to contact the driver of unit 1. He stated that he did not know that he hit unit 2. Unit 1 driver is cooperative with this incident.

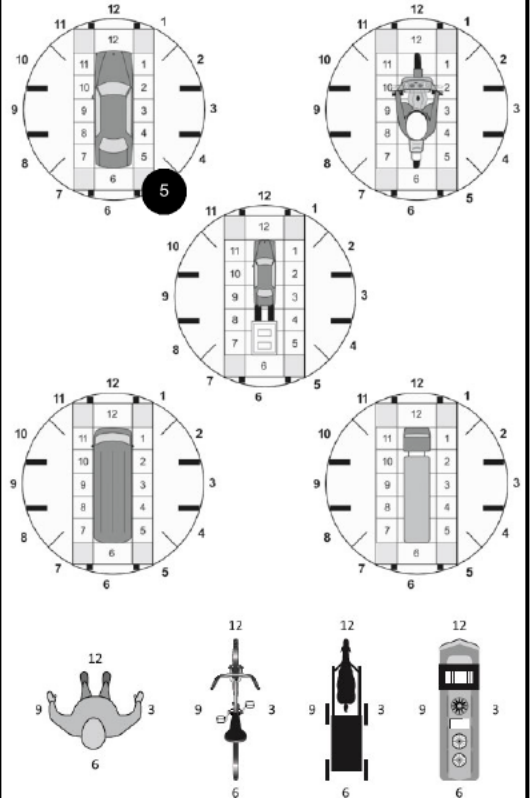
