UNIT 2 THEN ATTEMPTED TO CROSS THE INTERSECTION AND CONTINUE STRAIGHT ONTO SHADOWY HILLS. WHILE UNIT 2 WAS CROSSING, UNIT 1 ENTERED THE INTERSECTION AND ATTEMPTED TO COMPLETE A LEFT TURN ONTO BONHAM. 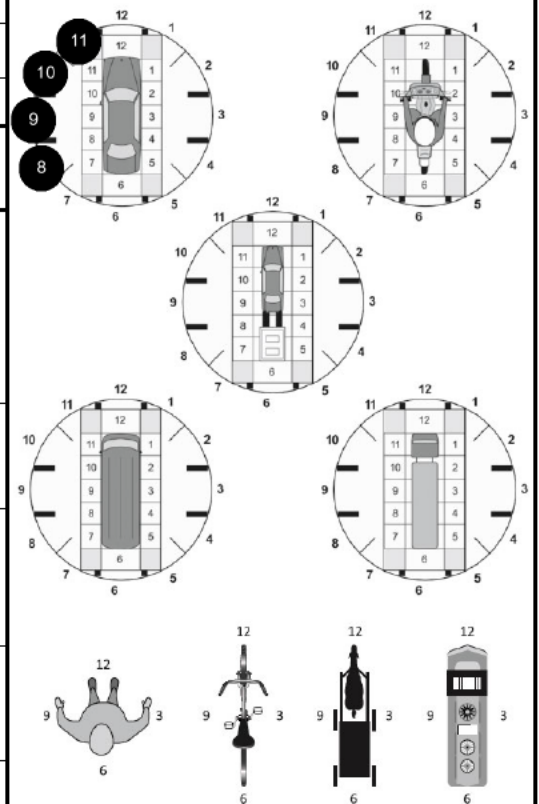
