<b>NARRATIVE</b> Unit 1 was turning left coming from Reagan PL. While making the turn, Unit 1 stated he did not see the pedestrian pushing a stroller in the crosswalk and struck the stroller, causing a baby to come out of the stroller and hit the ground on the baby's head. The pedestrian stated that she had the signal to walk and was a few steps into the crosswalk when Unit 1 came through the intersection, hitting the stroller, causing her to fall to the ground and the baby to fall out of the stroller. The baby sustained an apparent head injury and was taken to the hospital by EMS to be evaluated. It is unknown at this time which unit is at fault.

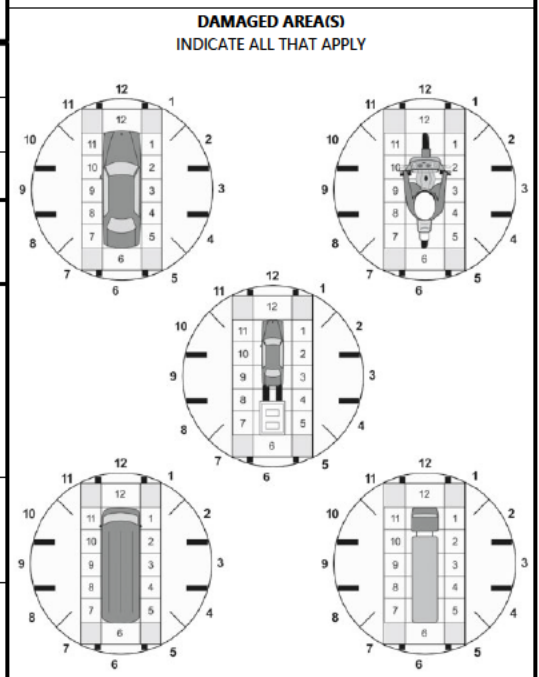
