Unit 1 attempted to turn north onto Morning Sun Rd and failed to yield to the right of way of the westbound Unit 2, striking Unit 2. Unit 1 and Unit 2 driver both advised a separate vehicle turned south onto N Main St from E Sycamore St, possibly obstructing the view to Unit 1. A witness advised that they observed Unit 1 turn into Unit 2 and upon putting their vehicle into park in the southbound lane of Morning Sun Rd and approaching the crash, they observed that the traffic light for north and southbound traffic switched to green. This indicated to them the light was either green or yellow for the east and westbound traffic during the events.

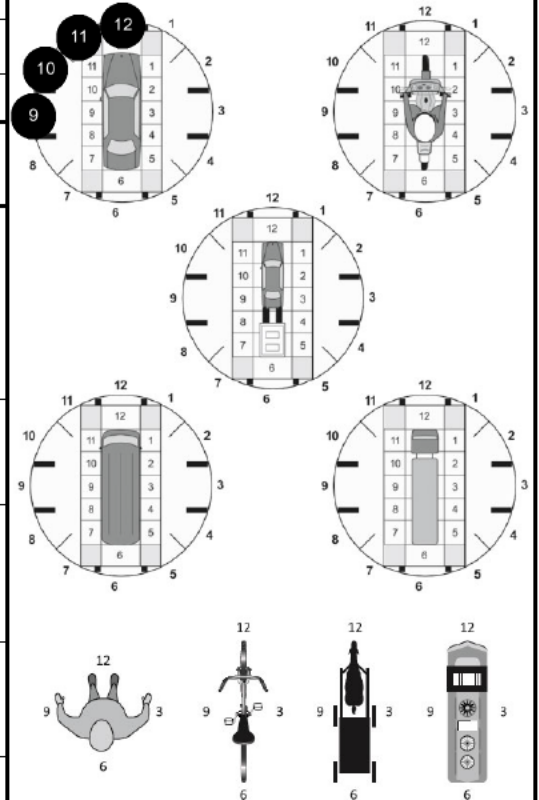
