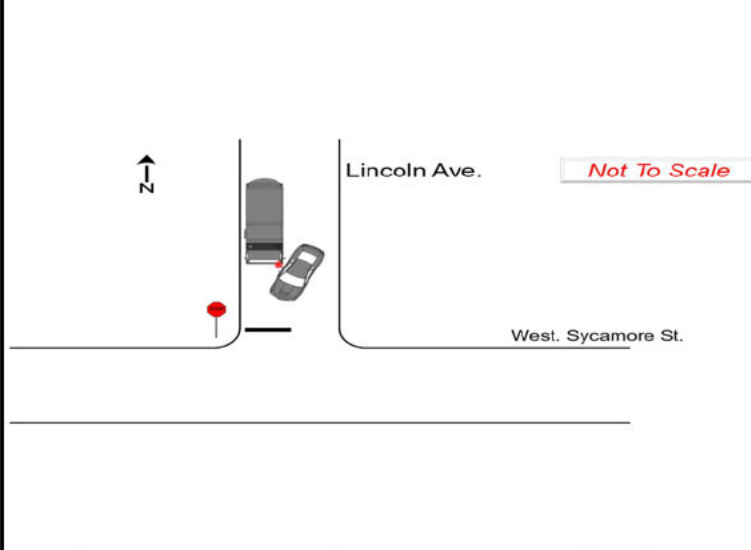

Sycamore St. As driver of Unit 1 began to proceed forward, he did not see Unit 2 had attempted to go around him and Unit 1 struck Unit 2 in the passenger side door causing damage to the passenger side door and external mirror.  Driver of Unit 2 stated that she and a car in front of her had gone around Unit 1 as it was still stopped loading trash. Driver of Unit 2 stated the car in front of her was making a turn on Sycamore St. and she was still sideways in front of Unit 1. Driver of Unit 2 stated that while she was stopped straddling both lanes, Unit 1 proceeded forward and struck the passenger side of Unit 2.

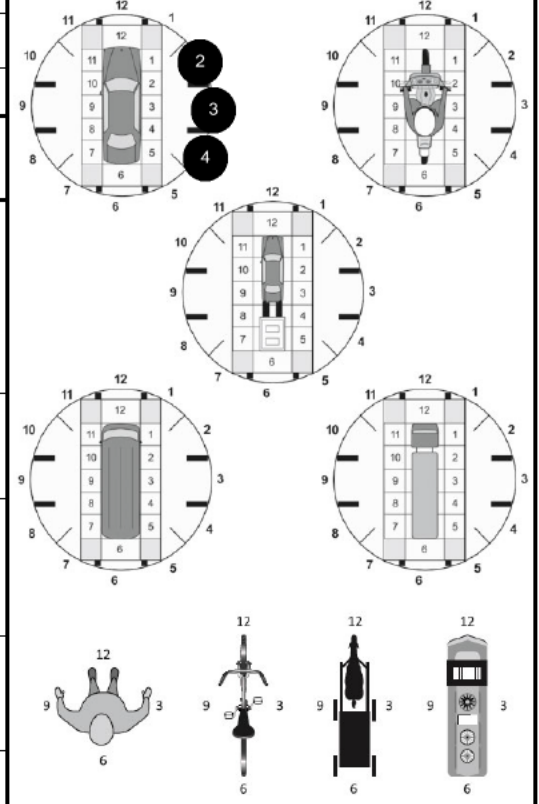
