NARRATIVE Unit 2 turned into the parking lot of 36 Lynn Ave (Taco Bell) from the southbound lane of Lynn Ave. While Unit 2 was turning into the parking lot, Unit 1 attempted to back out of a parking spot. Unit 1 slowly reversed, and the passenger side of the bumper came into contact with the grill and front end of Unit 2, causing paint transfer.  Unit 1 driver stated that he did not see Unit 2 behind him and advised that he did not feel his vehicle came into contact with Unit 2.  While on scene, Unit 1 and Unit 2 exchanged information and declined to file a crash report.  On 4/18/25, Unit 2 reached out to request a crash report due to them not being able to contact Unit 1.

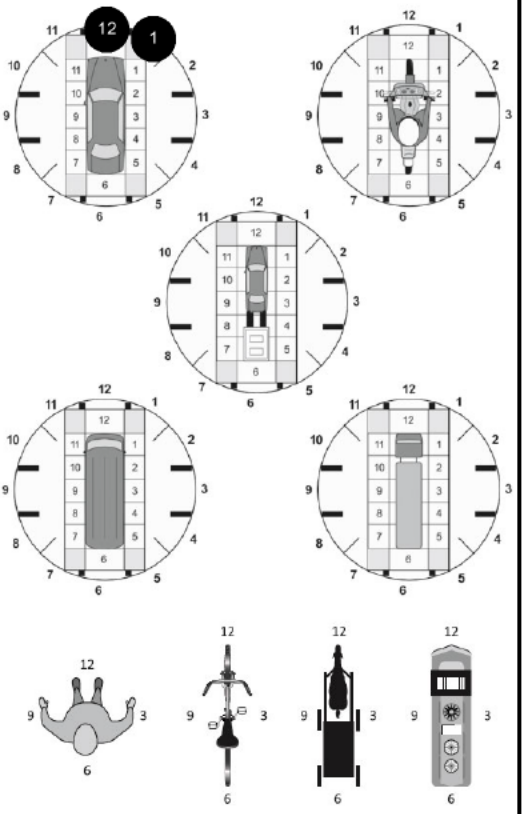
