NARRATIVE Unit 4 was traveling southbound on US 27, Unit 3 was traveling immediately behind Unit 4, Unit 2 was traveling immediately behind Unit 3, and Unit 1 was traveling immediately behind Unit 2. Unit 4 slowed to make a right hand turn into the parking lot of 4985 College Corner Pike. Unit 3 slowed behind Unit 4, and Unit 2 slowed behind Unit 3. Unit four failed to slow and stop prior to striking Unit 2 on the rear-end. This propelled Unit 2 forward into Unit 3, and Unit 3 was propelled forward into Unit 4. The Unit 1 driver stated at one point during our interaction that he looked up and everyone in front of him had stopped, but he couldn't hit his brakes fast enough to stop. An additional witness stated that the Unit 1 driver ad been looking down prior to the collision. The Unit 3 driver was treated by Oxford Fire at the scene, and had to be transported to McCullough-Hyde Memorial Hospital for further evaluation on suspected minor injuries.

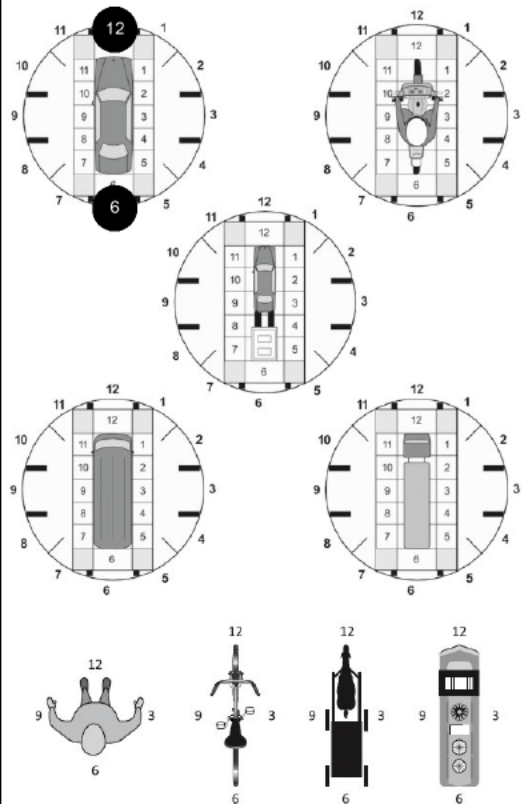

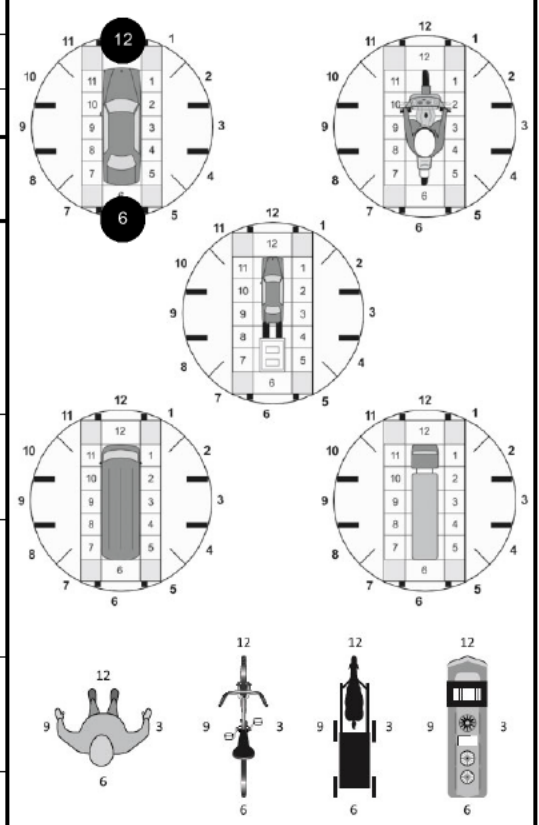

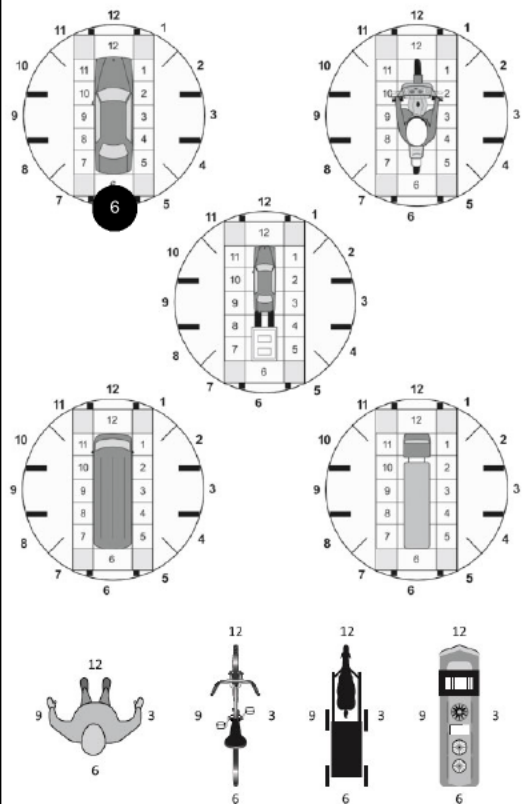
