

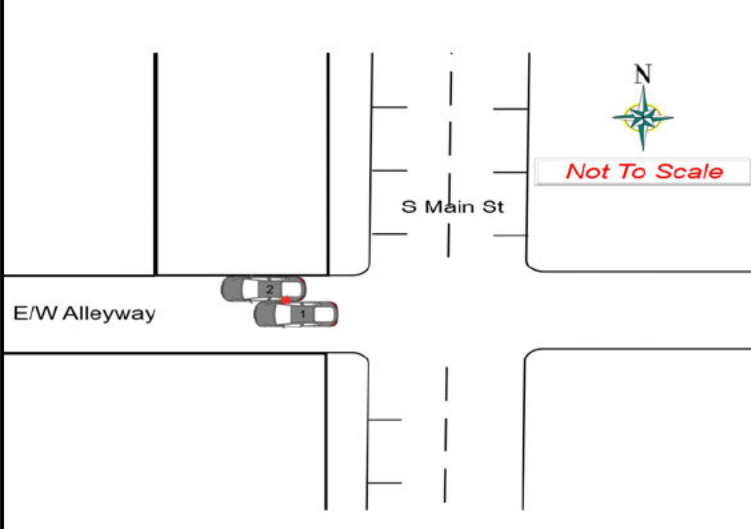

Main St. to continue westbound in the alleyway connecting with the 0 block of S. Beech St. Unit 2 was parked to the north side of the alley, loading the vehicle, facing westbound. An unknown section of Unit 1 made contact with the rear driver side quarter panel of Unit 2, just behind the rear wheel well. The result was transfer damage on Unit 2. The driver of Unit 1 was unsure of whether she had been driving northbound or southbound on S. Main St. prior to her turn into the alleyway. As such, she was unsure which part of the vehicle made contact. This is due to a large amount of pre-existing crash damage to the vehicle. Unit 1 was unaware that the vehicles had made contact, and left the scene.

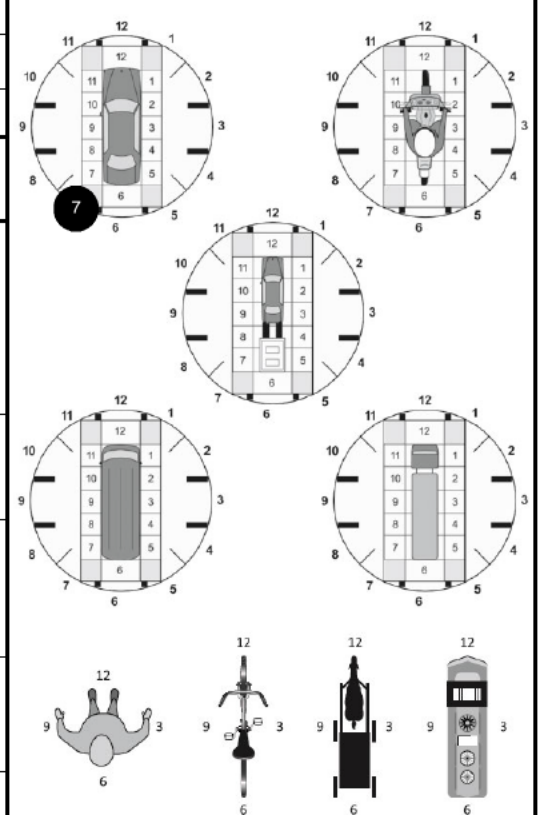
