NARRATIVE Unit 2 was parked in the parking lot of Schneider Electric, while Owner of Unit 2 was working. When the owner of Unit 2 got off work, she found damage to her vehicle. Business security cameras were checked and did not point to the area where Unit 2 was parked. Unit 2 suffered damage to the driver's side front quarter panel. Unit 1 had fled the scene. Time and details of crash are largely unknown. Update: A new camera angle was located showing the crash occurring at 2231 hours when a white truck (Unit 1) backed into the parked Miata. Driver of Unit 1 was eventually identified and claimed he thought he had struck a snow pile before leaving the parking lot. 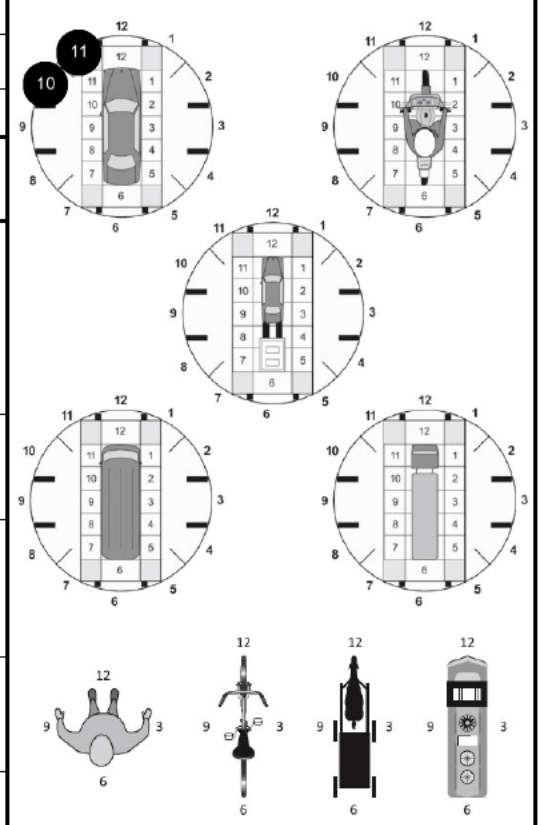
