NARRATIVE Unit 2 was traveling northbound on Bonham Rd, slowing to a stop in order to make a left turn into the parking lot of 5200 Bonham Rd. Unit 1 was the second vehicle behind Unit 2 traveling in the same direction. As Unit 2 initiated their left turn, Unit 1 attempted to pass both vehicles on the left side, in a double yellow no passing zone. The front right bumper of Unit 1 made contact with the rear left body of Unit 2, causing disabling damage to Unit 1, and significant cosmetic damage to Unit 2.
