NARRATIVE Unit 1 was traveling southbound on Southpointe Parkway. Unit 2 was traveling southbound on Southpointe Parkway, immediately behind Unit 1. As they approached the intersection with Magnolia Dr, which is also the entrance to 3604 Southpointe Parkway, Unit 1 suddenly activated the right turn signal, and began to pull toward the entrance to the above address. As Unit 1 began to move to the right, Unit 2 continued forward. Unit 1 then suddenly activated a left turn signal, and attempted a left turn onto Magnolia Dr. Unit 2 had pulled nearly parallel with Unit 1 at the time of the sudden change, and the front left quarter panel of Unit 1 made contact with the front right quarter panel of Unit 2, as Unit 2 passed.

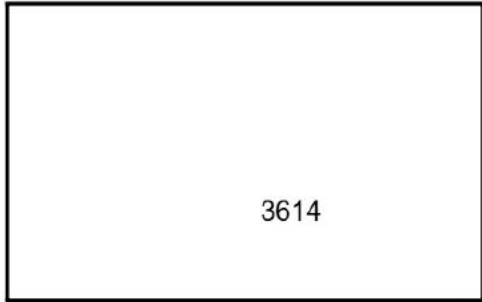
