NARRATIVE Unit 1 was driving eastbound on Contreras Rd at around 45 mph. The driver of unit 1 was speaking with the passenger, and while talking, the driver took his eyes off of the road to look at the passenger. The driver steered the vehicle off of the roadway onto the roadside, striking a concrete culvert in front of 6225 Contreras Rd. Unit 1 cracked the concrete culvert in half and detached it from the asphalt. Unit 1 sustained disabling damage, as the front passenger wheel and axle was completely destroyed. Every airbag in the vehicle was deployed. Unit 1 driver admitted to being intoxicated and was arrested for OVI. Vehicle was towed from the scene.
