NARRATIVE UNIT 2 WAS SLOWED/STOPPED IN TRAFFIC AT 110 S. LOCUST ST. HEADING NORTH. UNIT 1 WAS TRAVELING NORTH AS WELL. UNIT 1 THEN STRUCK THE REAR OF UNIT 2 CAUSING DISABLING DAMAGE TO UNIT 2. UNIT 2 APPARENTLY RAN IN TO THE BACK OF A VEHICLE IN FRONT OF IT STOPPED IN TRAFFIC AS WELL. HOWEVER, THE DRIVER OF UNIT 2 STATED A MALE WHO WAS DRIVING THE VEHICLE ADVISED THAT HE WAS JUST GOING TO LEAVE AND DID SO BEFORE POLICE ARRIVED ON SCENE. THAT UNIT AND DRIVER HAVE NOT REPORTED THE INCIDENT TO POLICE. UNIT 2 ALSO RECEIVED FRONT BUMPER DAMAGE FROM STRIKING THE UNKNOWN VEHICLE IN FRONT OF IT. THE DRIVER OF UNIT 1 WAS A JUVENILE AND WAS CITED FOR ACDA. UNIT 2 WAS TOWED. NO DAMAGE WAS REPORTED FOR UNIT 1. NO INJURIES WERE REPORTED AT THE SCENE.

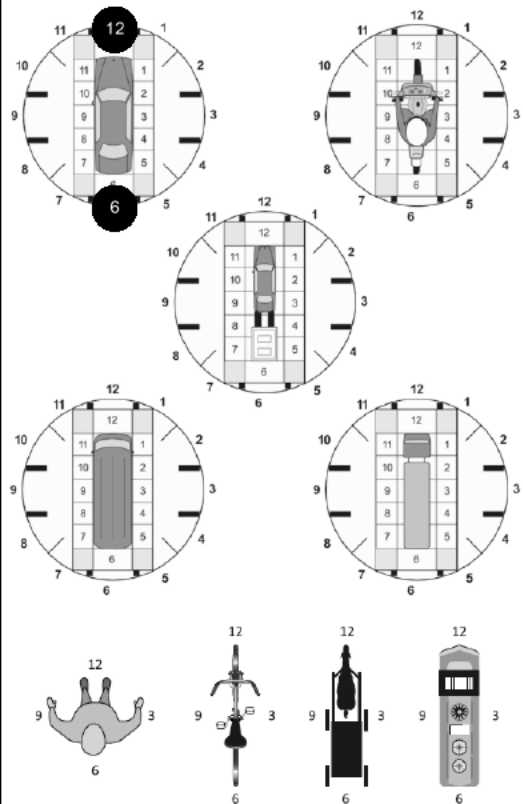
