THE OFFICER STATED THAT UNIT 2 STARTED TO TRAVEL SOUTH THROUGH THE INTERSECTION WHEN UNIT 1 STRUCK THE PASSENGER SIDE OF UNIT 2 CAUSING NON-FUNCTIONAL DAMAGE TO THE VEHICLE. THE PLAIN CLOTHES OFFICER WHO WITNESSED THE CRASH STATED THAT UNIT 2 HAD STOPPED AT THE STOP SIGN AND HAD ALREADY STARTED INTO THE INTERSECTION WHEN HE OBSERVED UNIT 1 TRAVEL EAST THROUGH THE STOP SIGN AT POPLAR ST. AND STRIKE UNIT 2. UNIT 1 SUSTAINED COSMETIC DAMAGE ONLY. NO INJURIES WERE REPORTED.

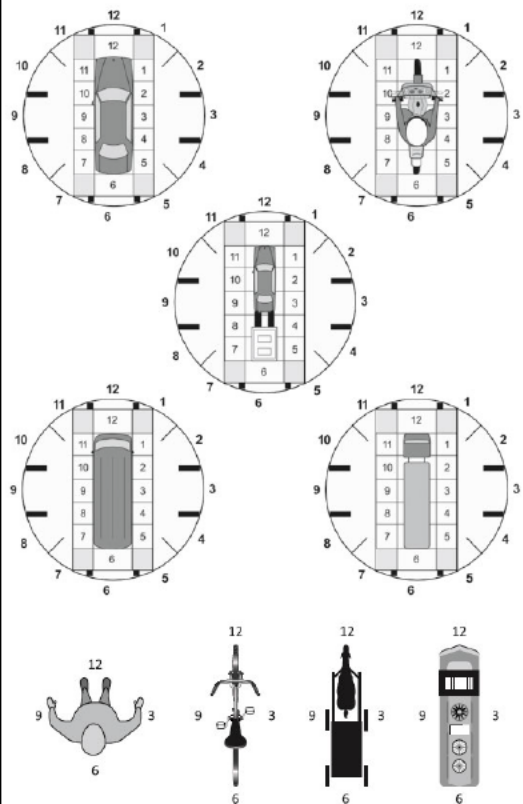
