Church st. while facing eastbound. Unit 1 attempted to park in between two vehicles and was not successful at the first attempt. While still both partially in a parking spot and in the eastbound lane of travel, driver of Unit 1 waived a waiting eastbound truck to go around Unit 1. As the truck went around Unit 1, Unit 1 then attempted to pull back out into the eastbound lane a bit and was hit by Unit 2 that was traveling eastbound behind the truck.</p> <p>Driver of Unit 2 stated that she was eastbound behind a truck that had slowed and then continued eastbound. Driver of Unit 2 stated that as she attempted to speed back up and continue eastbound behind the truck, she struck Unit 1 before she was even able to see Unit 1. Driver of Unit 2 thought that Unit 1 must have pulled out of a parking space as she was passing by.</p> <p>Both drivers and the sun share some responsibility for this crash and they were advised that a report would be filed.</p>
