There was a white Jeep directly behind Unit 2 that braked and drove into the shoulder to keep from hitting Unit 2. Unit 1 was behind the white Jeep and swerved onto incoming traffic to avoid hitting the Jeep. As oncoming traffic was coming towards Unit 1, they swerved back towards their lane of travel and side swiped Unit 2, causing the bumper to be peeled off.
