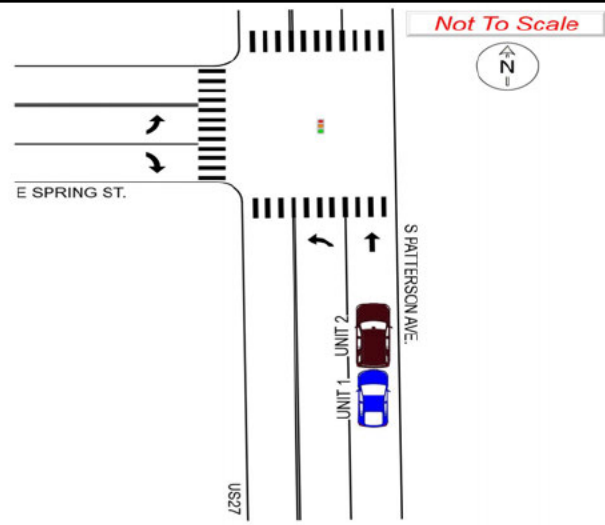

 UNIT 2 HAD BEEN DRIVING NORTH ON S PATTERSON AVENUE AND HAD THEN COME TO A STOP IN TRAFFIC, JUST SOUTH OF THE INTERSECTION OF S PATTERSON AVENUE AND E SPRING STREET. UNIT 1 WAS ALSO DRIVING NORTH ON S PATTERSON AND WAS DIRECTLY BEHIND UNIT 2. AFTER UNIT 2 HAD COME TO A STOP, UNIT 1 CONTINUED FORWARD, ULTIMATELY STRIKING THE REAR OF UNIT 2.
