NARRATIVE Driver of Unit 1 stated that she was stopped in traffic behind Unit 2 when Unit 2 began to move forward. Both units were stopped in traffic due to eastbound traffic backed up from a traffic signal ahead at the intersection of SR732 and S. College Ave. Driver of Unit 1 stated that Unit 2 then stopped abruptly in traffic after moving briefly and Unit 1 could not get stopped in time and rear-ended Unit 2. Driver of Unit 2 stated that she was stopped in traffic due to a back-up for a traffic light ahead. Driver of Unit 2 stated that while stopped in traffic, she got rear-ended by unit 1. Driver of Unit 2 did not know if Unit 1 had already stopped once during the back-up, or if Unit 1 just never stopped and rear-ended her. Both Units had minor damage to the bumper areas.

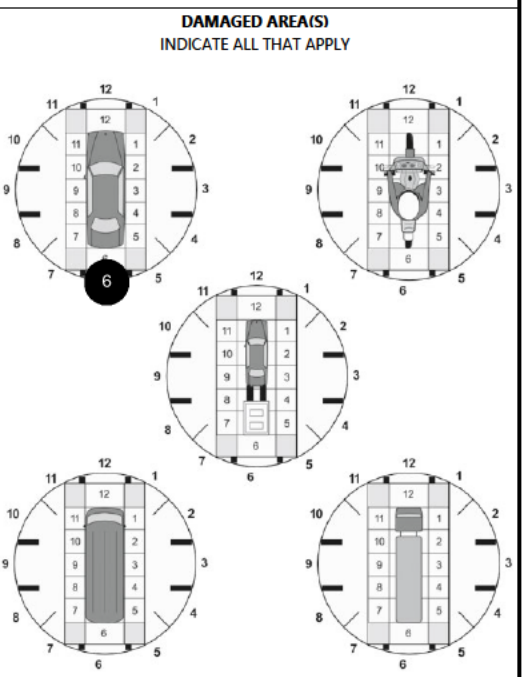
