NARRATIVE Unit #1 (electric bicycle) was riding east on the sidewalk to the south of E High St (US 27). Unit #2 was traveling west on E High St. Unit #1 made a left turn (north) into a marked crosswalk at a rapid pace, crossed the eastbound lane, through a cutout in the raised median and into the westbound lane, directly in the path of Unit #2. Unit #2 struck Unit #1 as Unit #1 failed to yield or clear the roadway. The operator of Unit #1 rolled onto the hood and hit the windshield of Unit #2. Unit #2 braked and operator #1 rolled off the hood and onto the pavement sustaining minor injuries. The collision was captured on traffic camera. The footage has been burned to a CD and placed into our evidence room.

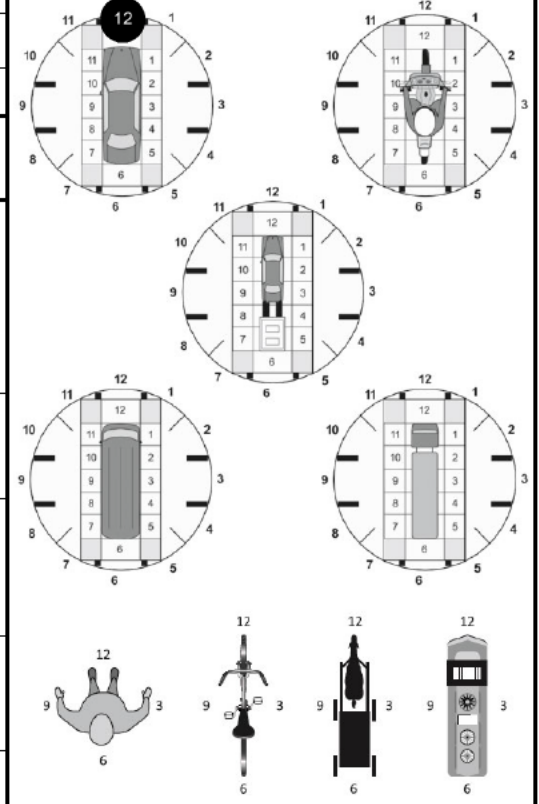
