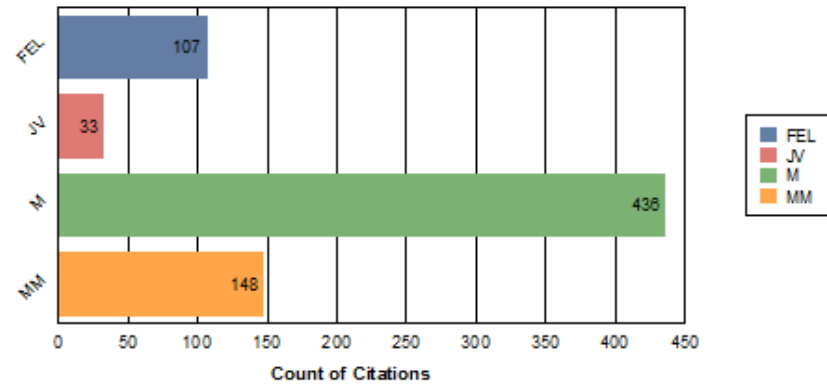

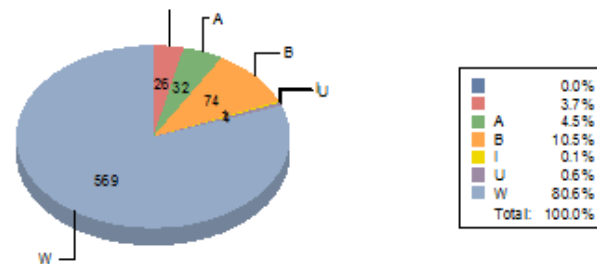

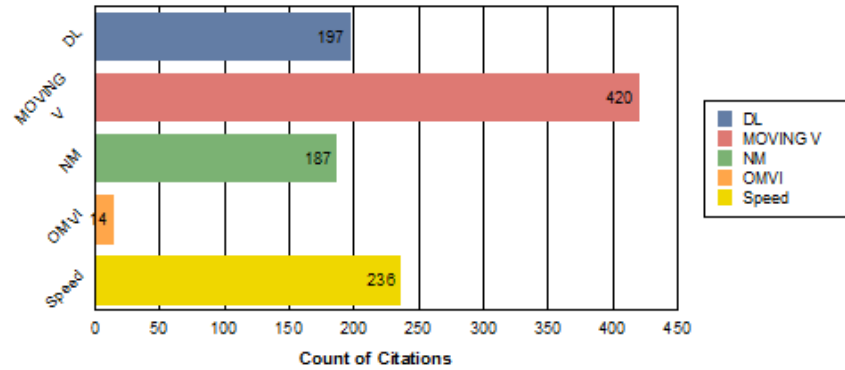

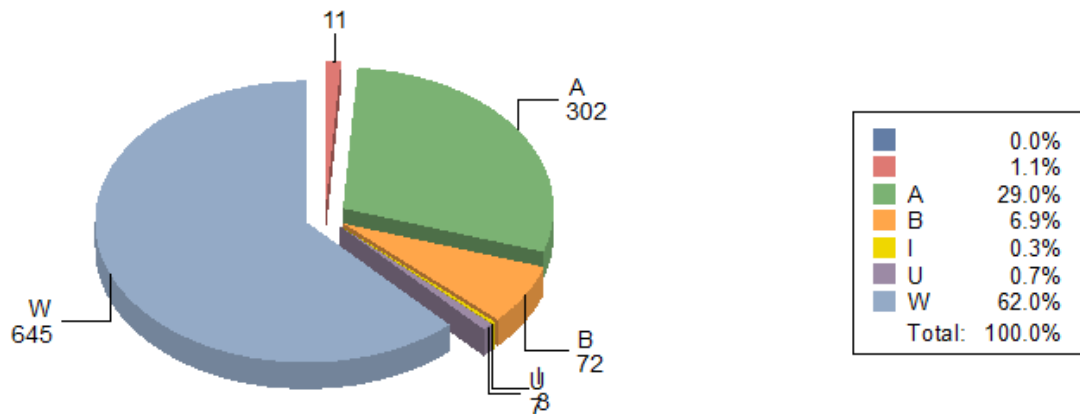


Traffic Citation Breakdown

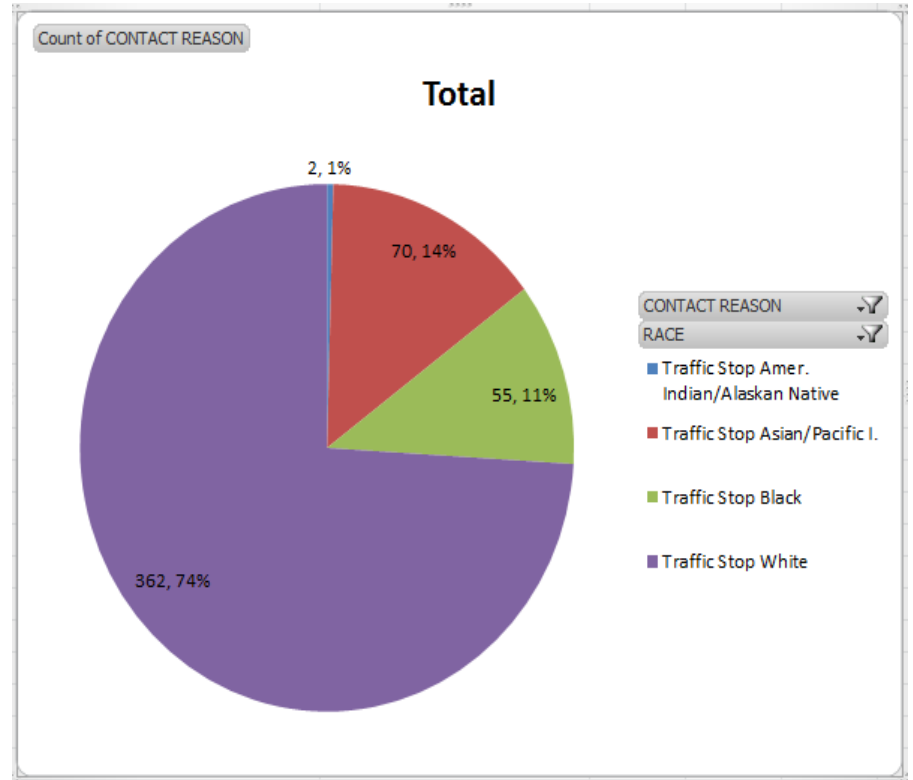

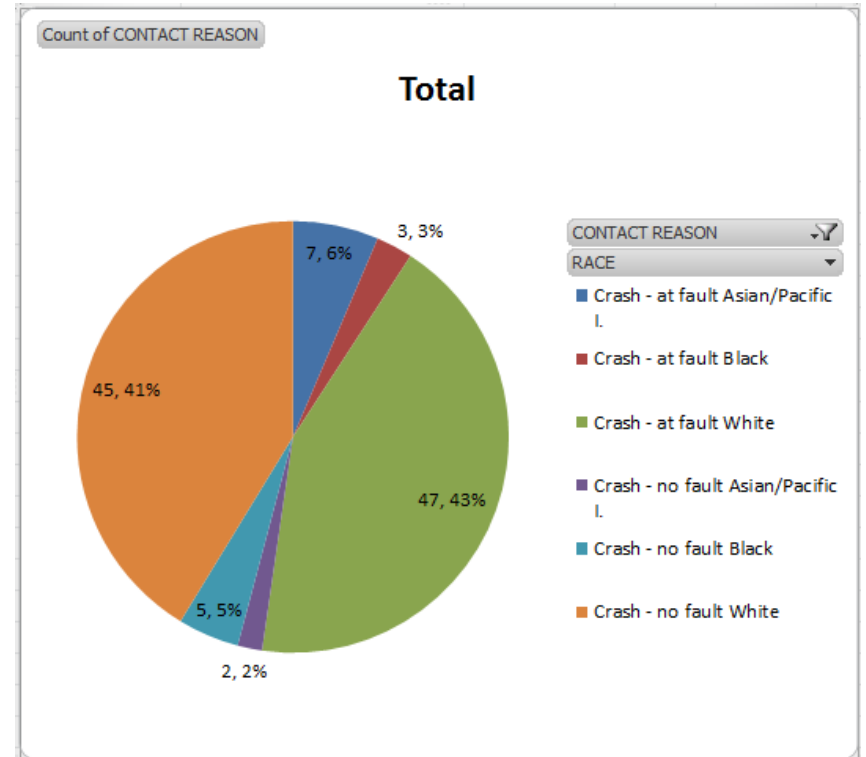
Traffic Stop Data
